The meeting was opened for the transaction of business by the Mayor and the following business was transacted:

A motion offered by W. O. Harrison that the Town of Walnut Grove pay the expenses of sending Attorney J. E. Smith to Atlanta, Ga., to expedite the application for a loan from the Housing and Home Finance Agency to be used in construction of a water and sewage disposal system for the Town of Walnut Grove, was seconded by Mac Dawson and passed by unanimous vote.


On a motion made by W. O. Harrison and seconded by Mac Dawson, the Board by unanimous vote ordered the acceptance of a renewal of Mississippi Power Company's Contract.

The following order was passed by the Board:

ORDER AUTHORIZING THE RENTING OF AN ADDING MACHINE TO BE USED FOR THE TOWN OF WALNUT GROVE AND AUTHORIZING PAYMENT OF RENTAL

There came on to be considered the matter of renting an adding machine to be used for the Town of Walnut Grove, Mississippi. Upon motion duly made and seconded, it was ordered by the Mayor and Board of Aldermen of The Town of Walnut Grove, that an adding machine be rented from the Carthaginian for a period not to exceed Three Months, at \$56.50 per month, payable in advance, said motion having received the unanimous vote of all members of the Board present, the Town Clerk is hereby ordered and directed to issue the warrant of the Town in payment of said rent when the same shall become due and payable.

RESOLUTION AUTHORIZING THE RENTING OF A TRACTOR
AND MOWER TO BE USED FOR MAINTAINING STREETS,
AUTHORIZING PAYMENT OF RENTAL, AND RELATED PURPOSES

There came on for consideration the matter of renting a tractor and mower for use in maintaining streets of the Town of Walnut Grove, Mississippi, and the matter having been discussed, and it appearing to the Mayor and Board of Aldermen of the Town of Walnut Grove, Mississippi, that the best interest of said Town would be served by renting a used tractor and used mower for use in maintaining the streets of the Town, and that C. D. Lewis has a good used Cub Tractor and Mower that he is willing to rent to the Town for a period of Five Months, at a monthly Rental of Eighty Dollars per month, and that this is the best rental that can be obtained in the premises, upon motion duly made and seconded, it was Ordered that the Mayor, W. C. Dawson, be and he is hereby authorized to rent said tractor and mower from C. D. Lewis for a period of not to exceed Five Months at a monthly rental of \$80.00 per month, payable in advance, said motion having received the unanimous vote of all members of the Board present, and that the Town Clerk be and she is hereby directed to issue the warrant of the Town in payment of said rent when the same shall become due and payable; It was further ordered that the Town pay for all gasoline, repairs and upkeep of said tractor while it is being used by the Town.
