MINUTES OF REGULAR MEETING OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF WALNUT GROVE, MISSISSIPPI HELD ON APRIL 7, 1981

BE IT REMEMBERED and it is hereby certified to that the Mayor and Board of Aldermen of the Town of Walnut Grove, Mississippi met in regular session on Tuesday, April 7, 1981 at the City Hall at 6:00 P.M. this being the time and place for said meeting. The meeting was called to order by the Mayor, W. C. Dawson.

The following business was transacted to-wit:

On motion by Alderman Starling, seconded by Alderman Bryan the Board unanimously approved the refunding of \$44,811.35 to its gas customers as determined necessary by the Town's Tarriff agreement with the Mississippi Public Service Commission. is the amount, including interest earned, which United Gas Pipeline refunded to the Town as a result of an order from the Federal Power Commission. The expenses incurred in refunding this amount will be taken from the said \$44,811.35, with the balance being prorated to the gas users.

The Mayor and Clerk are hereby authorized to make arrangements with Butcharts & Associates of Canton for any accounting assistance needed to make the refund, and any other assistance needed. The Clerk is to notify the Public Service Commission that steps are being taken to make the refund.

Several ladies from the Mississippi Library Commission and local citizens met with the Board to discuss possibilities of a library expansion. Several possible floor plans and methods of financing werediscussed. A motion was made by Alderman Spence, seconded by Alderman Starling that the Town make application with the Mississippi Library Commission for a possible grant to help finance this addition.

It appearing to the Mayor and Board of Alderman of the Town of Walnut Grove that heretofore by Minutes of said Board dated March 3, 1981 of record in Minute Book 6 at page 156 thereof, said Town's Minutes, that a resulution was duly passed and adopted, wherein certain real property owned by the Town of Walnut Grove, described hereinafter, was authorized to be sold pursuant to Local and Private Senate Bill No. 3076 as passed by the Senate of the Legislature of the State of Mississippi, and

It further appearing that the real property ordered sold is presently claimed and occupied by Mrs. Joe Upton, a/k/a Mrs. Beatrice Upton, and

It further appearing that said real property is located in the Town of Walnut Grove, Leake County, Mississippi, described as follows:

Lot 5, Block B, HOWARD CLARK ADDITION to the Town of Walnut Grove, all according to Plat Book 2 at page 27 thereof, as filed of record in the Office of the Chancery Clerk of Leake County, Mississippi,

The same being also described as follows: A lot 84 feet wide North and South by 125 feet East and West in Wo of SEL, SEction 27, Township 9 North, Range 8 East, described more particularly as follows: Start at the intersection of the North line of Rimmer Street and the West line of Lindsey Street in the Town of Walnut Grove, Leake County, Mississippi, and run thence North 84 feet and here establish the Point of Beginning, run thence West 125 feet, thence North 84 feet, thence East 125 feet, thence South along west boundary of said Lindsey Street 84 feet and back to point of beginning.

It further appearing that said real property was duly and legally sold in strict accordance with said resolution of March 3, 1981, and the terms and provisions of said Benate Bill, and that there appeared at the time and place of said sale Rev. Marshall Sharp, who entered a bid of \$1.00 on behalf of Mrs. Joe Upton a/k/a

Mrs. Beatrice Upton, be being the only bidder present, and that said purchase price was received by the Town Clerk and receipt furnished to the proposed bidder, subject however, to the Town's approvel and confirmation of said bid at its next regular meeting, and

If further appearing that the Mayor and Board of Aldermen are now fully apprised of said sale and bid, and after a further discussion, upon proper motion having been made, seconded and the same unanimously carried by all of the Board of Aldermen,

IT IS RESOLVED that the bid of \$1.00 by Rev. Marshall Sharp, on behalf of Mrs. Joe Upton, a/k/a Mrs. Beatrice Upton, is declared the purchaser of said real property; that the Mayor and Town Clerk be, and they are hereby authorized, directed and empowered to execute a Special Warranty Deed on behalf of the Town of Walnut Grove to Mrs. Joe Upton, a/k/a Mrs. Beatrice Upton, conveying the above-described real property therein.

Mr. Robert Ratliff of Grenad met with the Board to explain his bid price of \$28,698.00 on cleaning and repairing the well, as per bid opening as of March 10, 1981, and to further explain the method of same he would use if he were awarded the bid. On metion by Alderman Spence, seconded by Alderman Sims, the Board voted to continue to hold the bids in abeyance until written clarification is obtained on the Ratliff Company's bid.
