After prayer by Aldermen, Leon Young, the following business was transacted to-wit:

The Mayor requested overtime pay of 8 hours for Deputy Howard Watkins for his extra hours worked due to another Officer not being able to come to work. This overtime pay was approved on motion made by Aldermen Don Gomillion, seconded by Aldermen Marcus Ellis, and an "AYE" vote by all the Aldermen present.

The Gas System Rate Refund account was approved for closing out and transferring into Gas System Operation Funds on motion by Aldermen Brian Gomillion, seconded by Aldermen Marcus Ellis and unanimously approved by all the Aldermen present.
